## Natural Mixed Tocopherols

**Product Description:** PrairiOX 45P is a cream to light tan free flowing powder with mild taste and odor, derived from edible vegetable oils (e.g. soybean, canola, sunflower) sourced from North America.

The typical mixed tocopherols composition is shown above. Due to variability of vegetable oil feedstocks from which the tocopherols are derived, slight variations will be found to this typical composition.

### Application

PrairiOX 45P is used as a natural antioxidant in a wide variety of applications. It prevents oxidation and rancidity in oily or fat-containing products to protect flavour and color. It is intended for use as an antioxidant in dietary supplements, food products, animal products and the cosmetics and personal care industry.

<b>Solubility</b>	Insoluble in vegetable oils and in organic solvents, but dispersible in water.		
<b>Stability/Storage</b>	The shelf life in sealed, original containers under normal storage conditions is at least 18 months after the date of manufacture. Unstable when exposed to oxygen and light, particularly in the presence of oxidizing agents or in alkaline media. The product darkens slowly upon exposure to air and light. Store in tightly closed containers, cool and dry. Do not refrigerate.

**Usage** For most oils and fats, the recommended concentration of tocopherols in the product will range from 100 ppm to 400 ppm on fat or oil content. For oils containing highly polyunsaturated fatty acids, tocopherol concentrations of up to 2000 ppm relative to the oil content may be necessary. It is recommended to test 3 different mixed tocopherol concentrations to determine the optimum level.
